In consideration of my minor child being permitted to participate in any way in Mystic Indoor Sports, LLC (“MIS LLC”) activities and being permitted to use the MIS LLC facilities, I, the parent and/or legal guardian of the minor below, for myself, my minor child and our personal representatives, assigns, heirs, and next of kin:

1. Acknowledge, agree, represent, and warrant that the use of MIS LLC facilities and equipment, participation in MIS LLC sponsored activities and events, and participation in any exercise activity in general is undertaken by my minor child at his or her own risk. I also agree and acknowledge that the use of MIS LLC equipment and facilities and exercise in general may involve a risk of injury and I represent and warrant that my minor child identified below is in good health and has no disability, impairment, injury, disease or ailment preventing him/her from using MIS LLC facilities and equipment or engaging in active or passive exercise or which would cause increased risk or injury or adverse health consequences as a result of my minor child’s use of MIS LLC facilities and equipment in any manner.

Acknowledge, agree, and fully assume all risks associated with the participation in any exercise activity at the MIS LLC facilities or the use of MIS LLC facilities and equipment, even if due to the **NEGLIGENCE** of MIS LLC, its board, officers, agents, employees, and contractors. I hereby agree to defend, indemnify and hold MIS LLC, its board, officers, agents, employees, landlords, and contractors harmless from and against any and all claims by my minor child, his/her family, personal representatives, assigns, heirs, and next of kin arising out of damage or injury to person or property occasioned by the use of MIS LLC facilities and equipment, participation in MIS LLC sponsored activities, or participation in any active or passive exercise or athletic regimen by my minor child at MIS LLC, even if due to the **NEGLIGENCE** of MIS LLC, its board, officers, agents, employees, landlords and contractors.
3. Acknowledge and agree that MIS LLC, its Board, officers, agents, employees, landlords, and contractors shall not be responsible or liable to my minor child, his/her family, personal representatives, assigns, heirs, and next of kin for articles damaged, lost, or stolen in, on or about any MIS LLC facility, or placed in any lockers, or for loss or damage to any property including but not limited to automobiles and the contents therein, and agree to fully assume all risk of damage or loss to any such articles or property.
4. I hereby give my consent to MIS LLC, its agents, employees and contractors to photograph, film, videotape and then use, reproduce, and publish said images of me and/or my child/children relating to the use of the MIS LLC facilities. I agree that photographs/negatives, film, or videotapes thereof shall constitute the sole property of MIS LLC with full right of disposition in any manner whatsoever, including the right to publish. I hereby release MIS LLC and its legal representatives and assigns from any and all claims whatsoever in connection with the use, reproduction, publication of the images thereof.
